Advantage Announces Monthly Distribution

(TSX: AVN.UN, NYSE: AAV)

CALGARY, ALBERTA – April 13, 2007 - Advantage Energy Income Fund ("Advantage" or the "Fund") announces that the cash distribution for the month of April will be \$0.15 per Unit. The distribution represents an annualized yield of 15.2% based on the April 12, 2007 closing price of \$11.84 per Unit.

The distribution will be payable on May 15, 2007 to Unitholders of record at the close of business on April 30, 2007. The ex-distribution date is April 26, 2007. The cash distribution is based on approximately 115.4 million Units outstanding.

The CDN\$0.15 per Unit is equivalent to approximately US\$0.13 per Unit if converted using a Canadian/US dollar exchange rate of 1.14. The US dollar equivalent distribution will be based upon the actual Canadian/US exchange rate applied on the payment date and will be net of any Canadian withholding taxes that may apply.
